## MEMBERSHIP LEVELS & DUES

### Executive Member

Executive Membership in JAHMA is available to professional property management companies who manage one or more federally, state, or locally subsidized or insured housing projects. This membership is available to employees at the management company office or regional managers. Executive Membership has 4 levels of membership from which to choose.

**Executive Member 1 \$175 annual dues**

The property management company with *one representative* eligible for member benefits.

**Executive Member 2 \$225 annual dues**

The property management company with *two representatives* eligible for member benefits.

**Executive Member 3 \$275 annual dues**

The property management company with *four representatives* eligible for member benefits.

**Executive Member 4 \$325 annual dues**

The property management company with *five or more representatives* eligible for member benefits.

### Property Member

Property Membership in JAHMA is available to Executive Member companies who are owners of such buildings. Please list properties owned and/or managed, using additional sheets if necessary. Benefits extend to all maintenance staff. Property Membership has 4 levels of membership from which to choose.

**Small Property Member \$125 annual dues**

*One manager or administrator is* eligible for member benefits.

**Medium Property Member \$195 annual dues**

*Two managers or administrators are* eligible for member benefits.

**Large Property Member \$250 annual dues**

*Three managers or administrators are* eligible for member benefits.

**Very Large Property Member \$275 annual dues**

*Four or more managers or administrators are* eligible for member benefits.

### Vendor Member

Vendor Membership in JAHMA is available to product service vendors doing business in the property management and maintenance area. Vendor membership is also available to professional service providers, banking services, legal, accounting and insurance service providers whose clients include property management companies.

**Vendor Membership \$325 annual dues**
